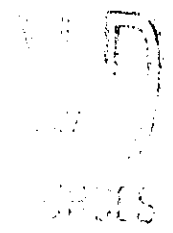

The Community Mental Health Department has requested consideration to reclassify one (1) vacant Registered Nurse position to one (1) Case Manager II position. The 2007 salary range for Registered Nurse is \$39,743 - \$49,678 and the 2007 salary range for Case Manager II is \$38,773 - \$48,467.

The reclassification of this position is necessary to ensure appropriate and manageable caseload assignment and will result in a budgetary savings of \$1,211.

Upon review of this request, I am recommending the Personnel Committee approve the reclassification of one (1) vacant Registered Nurse position to one (1) Case Manager II position. I have discussed this request with the Assistant Finance Director, who concurs in this recommendation.

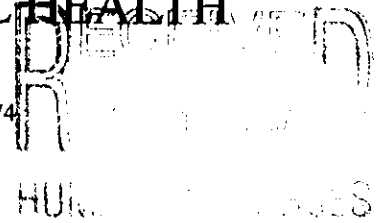

Since May, 2007, Macomb County Community Mental Health provides case management services to 98 children participating in the DD Children's Waiver Program. Currently, the program is staffed by six (6) full time case management positions. Due to the level of the intensity of services that is provided by case management and coordination for each child and their families, an additional Case Manager II position is needed to keep case load size manageable.

In addition, we will realize a small savings as the 2007 salary scale for the Registered Nurse position is \$39,743 to \$49,678 and the Case Manager II position is \$38,773 to \$48,467.

The request for the position reclassification has been approved by the Macomb County Community Mental Health Services Board on September 26, 2007. All relevant backup information is attached.
