## CAMPAIGN FINANCE REPORTING DATES TO REMEMBER

Committees that qualify for the \$1,000.00 Reporting Waiver are not required to file Annual Campaign Statements, Campaign Statements before and after primaries and elections or Triannual Campaign Statements.

Independent and Political Committees registered on the state level file three Campaign Statements a year on fixed dates; Caucus Committees registered on the state level file four Campaign Statements a year on fixed dates.

If your committee participates in a primary, a political party convention or an election not listed here, contact your filing official for applicable filing dates.

Pre-Election Campaign Statements close on the 16<sup>th</sup> day prior to the election and must be filed no later than the 11<sup>th</sup> day prior to the election; Post-Election Campaign Statements close on the 20<sup>th</sup> day after the election and must be filed no later than the 30<sup>th</sup> day after the election.

<b>Oct. 17</b>	Close of books for Pre-Election reporting period.

<b>Nov. 22</b>	Close of books for Post-Election reporting period.
<b>Dec. 2</b>	Post-Election Campaign Statement filing deadline.

(\*) An Annual Campaign Statement is not required of a committee that qualifies for the \$1,000.00 Reporting Waiver; a committee that files a Post-Election Campaign Statement during December; an Independent or Political Committee registered on the state level; an incumbent judge; or an officer whose salary is less than \$100.00 a month.
