Participants will shoot at a fixed distance depending on class. Clover Buds will shoot 5 yards (15 ft), Beginner 10 yards (30 ft.), Jr. and Sr. division 20 yards (60ft). FITA 60cm 10-point targets with 6 arrows and 5 rounds for scoring will be the format. Archers must shoot at 20 yards to qualify for the State Tournament.

Participants will shoot at 15 simulated animal targets over a variable distant field range. They will be given one (1) shot per target. Scoring will be 10, 8 and 5 on main body parts. No scores will be given to leg or headshots.
